Disqualification

- Miss obstacle while riding • Wrong line of travel • Steering outside course boundary • 1st refusal or evade • Dropping the rope gate and not picking it up • Fail to complete obstacle • Excessively or repeatedly touching fence • Obstruction of view that is such that attempt to perform obstacle • Performing obstacle out of order • In hand, horse goes loose or leading on the wrong side
